Blue Marble Space Institute of Science (BMSIS) is a non-profit research institute with an interdisciplinary approach to studying the relationship between Earth system science, space exploration, and the future of humanity (http://www.bmsis.org). BMSIS is pioneering a new Young Scientist Program (YSP). Alongside cutting-edge scientific investigations, students are also exposed to training in communication as well as ethics. BMSIS Young Scientists may work on-site or remotely, depending on the needs of the project, mentor, and Young Scientist. Funding is available for some projects but not all. Young Scientist positions last nominally a maximum of three months, although funded positions may last longer. BMSIS runs its own Young Scientist Program (the "BMSIS Young Scientist Program") that solicits applicants from around the world to work with a BMSIS mentor using remote collaboration tools. BMSIS also manages a collective of Young Scientists at NASA Ames Research Center (the "NASA/BMSIS Young Scientist Program in Space Biosciences") that all work with NASA Ames research mentors but complete their Communication and Ethics requirements with BMSIS mentors. During the summer of 2016, we hosted 13 participants in the BMSIS YSP and 23 participants in the NASA/BMSIS YSP. This past year was our third essay contest at BMSIS. This year's topic was "What would be the most

As of submission of this form 990, SAGANet has grown to have 1735 members, and over 12,000 social media followers on Facebook and Twitter combined. SAGANet also updated its newsletter to provide, monthly, the latest news relating to Astrobiology, career opportunities for early-career scientists, as well as upcoming meetings. The newsletter also advertises SAGANet exclusive events like our revamped "Ask an Astrobiologist" interview series, which is an upgrade from our previous "Talk to an Astrobiologist" series. This new series is more interactive and engaging. SAGANet also received donations to support a redesign of the website, which is now more esthetically appealing to the user. The mentoring program is under new leadership: a high-school teacher and a senior graduate student have taken the helm and preparing programs for calendar year 2017.

GreenSpace (http://www.growgreenspace.org/) is a permaculture center that specializes in microgreens, fresh herbs, and edible flowers. Guided by the latest research in sustainable farming, Greenspace is committed to the health of our planet, our families, and our customers. GreenSpace currently provides local produce to restaurants in Pennsylvania and Washington D.C. and participates in farmers markets and online community supported agriculture programs every week. We received funds from the S. H.A.R.E. non-profit organization that allowed us to improve the efficiency of our lighting system. We also hosted a meeting of the Southern Allegheny Chefs Association (a chapter of the American Culinary Federation) to allow chefs, food purchasers, and others in the culinary industry to tour our facility, learn about our growing methods, and sample our varieties of microgreens.
